As 2011 begins, I have been looking back at what we accomplished last year.

We brought back our newsletter, a vital link to our membership. We've been able to highlight the great work many of our chapters are doing; you will see more of that in this issue. All of the chapters have been encouraged to send items for inclusion in the CLUW News.

Our website is updated very often, with important information vital to the progress of our country.

E-Activists have been very busy taking action on many issues.

Our Cervical Cancer Prevention Works project educated thousands about the importance of HPV screening and vaccination.

We completed three installments of our Leadership Academy. NEB Members and other CLUW sisters and brothers took advantage of the outstanding speakers and workshops to help them become better leaders in the labor movement.

We held our first Working Women's Award Celebration where we honored some of the working women who have made a difference through their service to working families. This will be a biennial tradition.

We held a lobby day in conjunction with our March NEB meeting in Washington, DC. And CLUW members shared information with their respective legislators that are important to working women.

Our committees have been working on specific goals that each committee will carry out over the next two years. We are including more members in the committee work and continuing the work between meetings.

The Committee on the Future of CLUW will be presenting their recommendations at our Feb. Meeting.

We added 5 new chapters this year. The Northern VA Chapter, Milehigh Chapter in Denver CO, Northwest OH Chapter, Central CA Chapter and the Kate Mullany Chapter in Albany NY. All of them are excited and getting to work helping in many ways. Our chapters are our strength. We will continue to do what we can to support their efforts.

In the political arena we had some disappointments as labor friendly candidates lost their elections. However, there were some victories. Eleven members of our Detroit chapter ran for election and many of them won. In California the names of over 1000 women were submitted to Governor Brown for appointments in his administration.

Many of those names were of CLUW members. We will continue our work with the Women's Campaign Forum to encourage more women to run for office and to seek political appointments.

We saw movement on some of our legislative issues. They weren't all successful, but we moved things that we haven't been able to move at all in the Our legislative highlights Speaker Nancy Pelosi and are covered elsewhere in this $\frac{President\ Karen\ See\ (June\ 2010)}{President\ Karen\ See\ (June\ 2010)}$ issue.



Now we are looking forward to 2011. Work has already begun on our 16th Biennial Convention. Our fourth installment of the Leadership Academy is in the works. Our legislative efforts continue and we are putting together our program for the 2012 Elections.

We will continue to assist our unions to make sure the truth is told. We are going to be facing many challenges in our own communities as a reenergized movement tries to eliminate our right to organize and have a say in our workplaces. This may well be one of the toughest 2 years in recent labor history. But we are up to the challenge.

We will continue to educate our sisters and brothers who are in the labor movement and others who are not. We will spread the word about why unions are so important for women. We will continue our struggle for the rights of working women and their families.

Dear U.S. Senate Leaders

CEDAW, the Convention on the Elimination of All Forms of Discrimination Against Women, is a landmark international agreement that affirms principles of fundamental human rights and equality for women around the world. As a practical blueprint for countries to achieve progress for women and gids. CEDAW has been used in other countries to reduce violence against women, ensure educational opportunities, and increase political participation

The United States is one of only seven countries that haven't ratified CEDAW. Ratifying CEDAW will strengthen the United States as a global leader in standing up for women and girls. The U.S. Senate leadership should continue America's proud bipartisan tradition of promoting and protecting human rights by making CEDAW a priority and ratifying CEDAW now.

CEDAW (The Convention on the Elimination of All Forms of Discrimination Against Women) - we are part of the CEDAW Task Force urging Senate ratification of this international agreement that addresses the human rights and equality of women worldwide. We are partnering with the Leadership Conference on Civil and Human Rights on a postcard campaign to have folks sign their names, add a message and have the postcards sent to their senators during the first guarter of 2011. CLUW National Corresponding Secretary Bennie Bridges joined Cervical Cancer Prevention Works Dir. Carolyn Jacobson at the CA Cervical Cancer-Free Summit in Nov., in Sacramento. The Summit brought together physicians, patients, and community organizations to encourage women to take action to ensure that they never get this preventable form of cancer. The CA initiative, coordinated by the CA Medical Assoc. Foundation, is part of a nationwide Cervical Cancer-Free campaign.

A key focus of the initiative is on groups at highest risk. As Latinas are at the highest, the CMA Foundation joined with New America Media to cohost a stakeholder meeting in December 2010 in LA, which brought together ethnic media, ethnic physicians and key partners in Los Angeles to discuss and identify strategies to address cervical cancer disparities within the Latina community. A number of CLUW members participated.



CLUW Supports Labor Unions - CLUW supported IAM's efforts to organize airline employees at Northwest and Delta and AFGE's efforts to represent TSAs (Transportation Security Administration) employees. We supported an effort by an IBEW local to address the needs of retired workers whose healthcare premiums were in jeopardy during a contract dispute. We supported the AFT in their efforts to fight layoffs of teachers in Rhode Island and elsewhere. We are supporting the APWU in their struggles to protect the interests of postal workers against a Big Business agenda of dismantling the Postal Service. Working with our Labor Unions to support their struggles is a major priority for CLUW.

Social Security: the Coalition of Labor Union Women calls upon our elected officials to support the goals of the "Strengthen Social Security -Don't Cut It" coalition which states:

- Social Security belongs to the people who have worked hard all their lives and contributed to it. Social Security is a promise that must not be broken. If you pay in, then you earn the right to benefits for yourself, your spouse and your dependent children when you retire, experience a severe disability or die.
- We need to strengthen Social Security, not cut it.
- We need to oppose any cuts in benefits, including increasing the retirement age or privatizing Social Security in whole or in part.

Legislative Highlights 2010-2011

Health Reform - CLUW was very active in bridging the issues of the labor and the women's community in our education and lobbying efforts. We continue to educate our membership about the benefits of the Patient Protection and Affordable Care Act and will vigorously defend it from all efforts to dismantle it by the new Republican majority in the House.. We are involved in a coalition working on implementation of the Women's Healthcare Act to ensure that guidelines developed by the Department of Health and Human Services include all preventative care and do not put restrictions or burdens on women who are seeking family planning care and contraceptives.

Jobs and Unemployment - It has recently been reported that the unemployment rate among all women (8.4 percent) is at its highest rate since the recession began — *its highest rate in over 25 years*. This is a critical issue for CLUW **Social Security** - See previous page.

Paycheck Fairness - On November 17th a minority of senators killed debate on the Paycheck Fairness Act by a 58-41 vote preventing discussion on the merits of the bill. Sixty votes were needed to defeat a Republican filibuster. The bill had been passed by the House of Representatives on Jan. 9, 2009 and had widespread support of the public, as shown in polling, and the White House. All Republicans voted against considering the bill. The Paycheck Fairness Act is a comprehensive bill that would create stronger incentives for employers to follow the law, empower women to negotiate for equal pay, strengthen federal outreach, education and enforcement efforts, and strengthen penalties for equal pay violations. As part of the Paycheck Fairness Coalition we will continue to fight to close the gender gap and support future legislation. The next Equal Pay Day is April 12, 2011. The Women and Workforce Non-Traditional Jobs Act - This will create a new federal grant program to help recruit, prepare, place and retain women in high demand, high- wage nontraditional jobs.

Healthy Families Act/Paid Leave- national legislation would guarantee workers seven paid sick days so that they can address the health needs of their families and themselves; various legislation is under consideration at state and local jurisdictions. The Philadelphia CLUW Chapter exemplifies local activity in this area. They participated in a lobby day which took place at the same time as a hearing on the subject in Harrisburg in August. The chapter has been involved in a lobby day at City Council; participated in a postcard and letter-writing activity to Council people, and expect to provide testimony and participants when a hearing is scheduled this spring. They also got the Philadelphia Council AFL-CIO and PA AFL-CIO to sign on as coalition partners and endorse the legislation

Unemployment Insurance Modernizing Campaign: Unemployment insurance systems need to be updated for the 21st century to take women's work and life patterns into consideration. The American Recovery and Reinvestment Act provides funding for states that adopt specific reforms to modernize their Unemployment Insurance systems and remove barriers to coverage for women and low-wage workers. CLUW has asked our chapters to get involved on the state level.
